1. Hospital Inpatient Quality Reporting Notice of Participation	<ul style="list-style-type: none"> No updates made.
2. Hospital Quality Reporting Data Accuracy and Completeness Acknowledgement (DACA)	<ul style="list-style-type: none"> Updated to simplify form by consolidating the list of requested elements.
3. Care Compare Request Form for Withholding/Footnoting Data for Public Reporting	<ul style="list-style-type: none"> Added the REHQR program. Removed COVID-19 HCP, except for the PCHQR Program, and SDOH measures due to rulemaking proposals.
4. CMS Quality Reporting Program APU Reconsideration Request Form	<ul style="list-style-type: none"> In the contact sections, separated “Name and Title” to have a line for Name and another line for Title. This is due to quite often the provider does not include their title.
5. CMS Hospital IQR Program Validation Review for Reconsideration Request Form	<ul style="list-style-type: none"> No updates made.
6. Centers for Medicare & Medicaid Services (CMS) Quality Program Extraordinary Circumstances Exceptions (ECE) Request Form	<ul style="list-style-type: none"> Revised form to reflect potential for ECE extension, rather than only exception. Updates to instruction language for clarity and proposed deadlines.

9. CMS Quality Reporting Validation Educational Review Form	<ul style="list-style-type: none"> No updates made.
10. Electronic Clinical Quality Measure (eCQM) Denominator Declaration	<ul style="list-style-type: none"> Updated the measures, the measure names, and the order of the measures to align with changes made in the HQR System.
