**TITLE OF INFORMATION COLLECTION:** Office of Regional Operations Region 3  
Registration Form for Convenings of Faith-Based and Non-Governmental Organizations

**PURPOSE:** In 2024, the Office of Regional Operations (ORO) Region 3 will conduct a series of convenings for a cohort of individuals from faith-based and non-governmental organizations in Philadelphia, Pennsylvania.

1. **Speed Networking: Expanding Partnerships & Empowering Communities.** Through this in-person networking event, the cohort will interact and develop beneficial and empowering partnerships. These partnerships will help to strengthen their organizations and communities.
2. **Budget 101.** Participants will learn how to develop budgets to expend grant funds in accordance with federal requirements.
3. **Writing for Impact.** Participants will learn techniques for writing clear and effective correspondence, media, grant applications, and reports.
4. **Program Evaluation 101.** Participants will learn basic methods for evaluating their programs and services.

To plan and coordinate the events, ORO Region 3 will ask participants to register and provide the following information: name, organization, email address, telephone number, photo consent, and special accommodations. This information will be used for planning purposes for the events.

**DESCRIPTION OF RESPONDENTS:** ORO Region 3 has a cohort of 60 individuals from faith-based and non-governmental organizations. They occupy various positions in their organizations, such as grant writer, program manager, and executive officer.
