Notes on completion of Certificate:

- 1 The Certificate can be issued only to ships entitled to fly the flags of States which are a party of MARPOL 73/78.
- 2 Ship type: Any entry under this column must relate to all relevant recommendations, e.g. an entry "Type 2" should mean Type 2 in all respects prescribed by the code. This column would not usually apply in the cases of an existing ship and in such a case should be noted "see paragraph 2.2".
- 3 Products: products listed in chapter 17 of the Code, or which have been evaluated by the Administration in accordance with 1.8 of the Code, should be listed. In respect of the latter "new" products, any special requirements provisionally prescribed shall be noted.
- 4 Products: The list of products the ship is suitable to carry should include the Noxious Liquid Substances of Category Z which are not covered by the Code and shall be identified as "chapter 18 category Z".

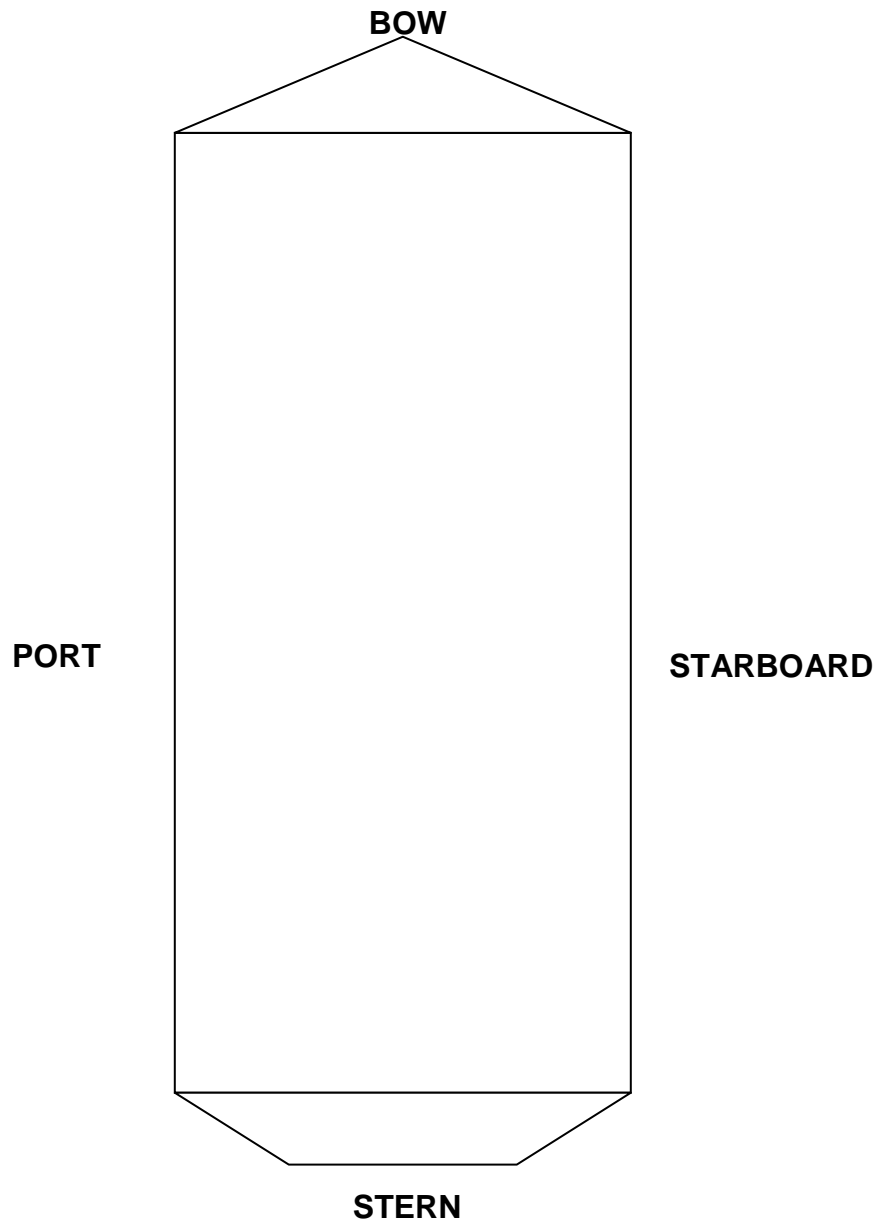
