Get Started With MyCAA

Your My Career Advancement Account and My Spouse Education and Career Opportunities account work together to help you meet your education and career goals. The MyCAA Scholarship application process leverages your MySECO profile and connects you to a career coach to help you make smart educational decisions and prepare you for a career that works with your military family's mobile life.

Traitify

Traitify, a visual personality assessment, helps you understand how your qualities and passions relate to potential careers by recommending career options based on your interests, aptitudes and education level. This assessment takes about 90 seconds to complete, and will instantly give you:

- A breakdown of where you align against seven types of career personalities
- Information about the kinds of people and work environments that help you thrive
- Possible strengths and weaknesses
- Personalized recommendations for careers aligned specifically with your unique characteristics

Traitify provides essential details about career recommendations, including the level of education and degree you need, as well as what to expect in terms of salary, potential job growth and more.

Check Your Eligibility

The first step in applying for the My Career Advancement Account Scholarship is to determine if you are eligible. Our system will check your eligibility when you log in with your DS Logon. More detailed information on eligibility can be found in the **MyCAA FAQs**.

Eligible spouses include:

- Spouses of active-duty service members in pay grades E-1 to E-5, W-1 to W-2 and O-1 to O-2 who have successfully completed high school and have the ability to request tuition assistance while their military sponsor is on Title 10 military orders are eligible.
- Spouses married to members of the National Guard and reserves in these same pay grades are eligible.

Those who are not eligible include the following:

- Spouses who are married but legally separated (or under court order or statute of any state or U.S. territory) from a member of the armed forces on Title 10 orders.
- Spouses whose National Guard or reserve military sponsor is in a warning orders or alert, post-deployment, demobilization or transition status.

Complete the MySECO/MyCAA Registration

To begin the registration, complete the following steps.

1. You can **register online** or call our SECO career coaches at 800-342-9647 for assistance.
2. Complete your MyCAA registration by reading the MyCAA fact sheet and terms and conditions, and successfully answer the quiz questions.
3. Fill in your personal information, education and training, and employment history.

Next Steps

Call the SECO Career Center to schedule your MyCAA coaching session with a SECO career coach.

If you have a career goal in mind, you can use the MyCAA School and Program Search to find schools and programs that interest you. These are great to discuss with your career coach.

If you have a school or program already in mind, contact them and request a MyCAA Education and Training plan. This plan includes your career goal and information about your chosen school, program and coursework. Your Education and Training plan must be approved before receiving financial assistance. Plans are reviewed and approved in the order in which they are received and can take up to 14 business days.

Save Time and Complete Prerequisites

Save time by completing prerequisite items first.

The MyCAA Scholarship application requires DS Logon. This is the same log in you may use to access TRICARE Online or MySECO. If you do not have a DS Logon or need to activate or upgrade, you can complete that on **Log in or Sign up**.

Military spouses must meet the following eligibility criteria to participate in the SECO program:

- You are a spouse of an active duty, National Guard or reserve component military member in the Army, Marine Corps, Navy or Air Force.
- You are a spouse of a military member separated from active duty, National Guard and reserves for less than 365 days.
- You are a surviving spouse of a military member who died while on active duty.
- You are not an active-duty military member.
- You are not a spouse of a Coast Guard military member.

3 Terms And Conditions

1. I agree that I am solely responsible for the establishment and management of my My Career Advancement Account Scholarship Account. Under no circumstances shall I share my account username or password with anyone, including but not limited to my military sponsor or school representatives.
2. I understand that I must have a high school diploma or general equivalency diploma (GED) to participate in the My Career Advancement Account Scholarship program.
3. I agree to develop an Education and Training Plan in coordination with school officials. I understand that a Spouse Education & Career Opportunities Career Coach is required to approve this plan prior to my requesting My Career Advancement Account Scholarship financial assistance.
4. I understand MyCAA funding is only available for 36 months from the start date of the first course funded by the My Career Advancement Account Scholarship program.
5. I understand that the maximum My Career Advancement Account Scholarship financial assistance benefit is \$4,000 and that there is a \$2,000 annual fiscal year spending cap.
6. I understand that My Career Advancement Account Scholarship funding cannot be used to audit, to repeat a course (unless the My Career Advancement Account Scholarship receives a full reimbursement), or to pay for non-academic credit / ungraded courses such as college / freshman orientation programs, internships, practicums or supervised clinical assignments.
7. I understand that I must submit a My Career Advancement Account Scholarship financial assistance (FA) request for each course in my Education and Training Plan on a course-by-course basis. FA request(s) must always be applied for by me no more than 60 days prior to the start date of the course/program. All FA requests must be applied for before the start of the course and before the Active Duty member's date of separation or when he/she is no longer serving on Title 10 orders. I understand that failure to do so will result in my being held responsible for pay course costs.
8. I agree to allow the Department of Defense and my school to share information which is necessary for the My Career Advancement Account Scholarship program administration and paying of school invoices. I understand I am responsible for ensuring that my grades are posted in the Academic Institution (AI) Portal within 60 days of course completion by school officials. I understand I will not be allowed to use additional My Career Advancement Account Scholarship funding until my grades are posted.
9. I understand if I fail or withdraw from a course, my My Career Advancement Account Scholarship program account will be suspended and no financial assistance requests can be applied for until I contact a Spouse Education & Career Opportunities Career Coach. If a second failure or withdrawal is made, I understand that I will not be allowed to receive any further funds from the My Career Advancement Account Scholarship.
10. I understand that if I receive a grade of incomplete, I am required to attain a satisfactory grade within 6 months of the course end date unless a shorter term is specified by my school. I understand that my account will be suspended and no additional My Career Advancement Account Scholarship funding will be provided until I complete this course.
11. I understand that waivers related to course failures, withdrawals and incompletes are authorized for "hardship" cases (e.g. unanticipated health issues, permanent change of duty location, temporary duty assignments, emergency leave of the military member, or hospitalization for a length of time that precludes course completion). Waiver requests must be signed by my military sponsor's supervisor or higher authority and uploaded into my My Career Advancement Account Scholarship Account eFile. They must include:
 - a. Name/title/code of course(s) for which the wavier is requested
 - b. Reason for the Wavier
 - c. Name, title and command for military sponsor's supervisor or higher authority

IN SUMMARY: I have read the above Spouse Terms and Conditions Agreement. I understand that non-compliance may result in (1) my being held responsible for tuition and examination costs; (2) indefinite suspension of my My Career Advancement Account Scholarship Account; or (3) in the case of fraud, permanent closure of my My Career Advancement Account Scholarship Account. 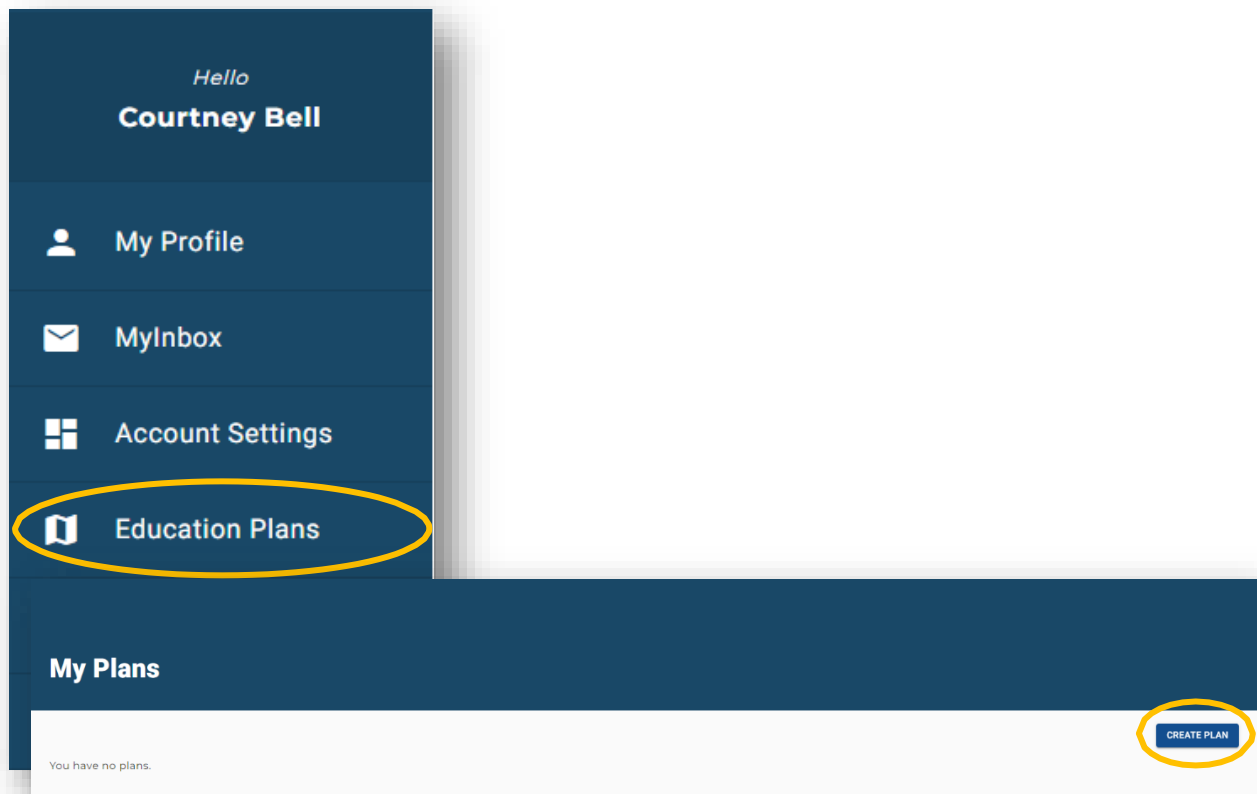

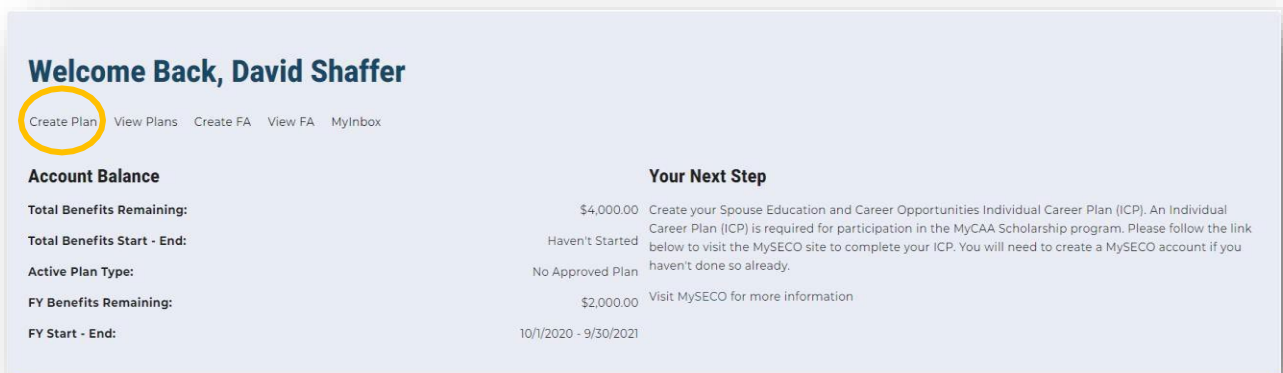
Education&Training (E&T) Plans
