- the organization's purpose is to provide education, support, and technical assistance to such service providers to enable the providers to establish and maintain supportive services and to provide shelter to survivors of domestic violence and their children;
- the organization is ready to serve as an information clearinghouse, primary point of contact, and resource center on domestic violence for the State of Oklahoma and to support the development of policies, protocols and procedures to enhance domestic violence intervention and prevention in the State of Oklahoma.
