SUPPORTING STATEMENT FOR PAPERWORK REDUCTION ACT SUBMISSION Accreditation Participation and Disclosures

This is a request for an extension without change of a currently approved collection, 1845-0156 Accreditation Participation and Disclosures. These regulations are §668.26 – End of an institution's participations in the Title IV, HEA programs and §668.43 – Institutional and programmatic information.

This information will be made available through various disclosures and used by enrolled and prospective students who are interested in educational programs offered by an institution.

There is nothing in the regulations which prevents the use of technology in the dissemination of the required information by the institution.

This information is not duplicated in any other information collection.

Due to the availability of technology to meet these disclosure activities, the Department does not believe the final regulations will adversely impact any institution that may meet the small entity designation.

If the collection required in these final regulations does not take place, institutions could run the risk of not meeting eligibility requirements and potentially face the loss of eligibility to participate in the title IV HEA student aid programs.

There have been no changes to the regulatory language and we are requesting an extension of the most recent burden assessed. We continue to estimate that 5,347 institutions will submit 17,116 responses for a total of 583,171 burden hours.
