- Firstly, how are retrieved from this system? We have a search screen. The search screen criteria only reflects the designator.
- Are they retrieved by an individual's unique identifier? The designator is the unique identifier for a company not for an individual.
- When a report is ran what individual's PII is retrieved (if any)? No individual's name is displayed when a report is retrieved. For FAA Form 8010-4, the individuals information is not saved to the database. It is for reference only in case we need to get hold of the individual.
