Individuals may apply to the Office of the Pardon Attorney, Department of Justice, for a restoration of federal firearms rights pursuant to Title 18, United States Code, Section 925 (c). Individuals may make application for relief from the disabilities imposed by Federal laws with respect to the acquisition, receipt, transfer, shipment, transportation, or possession of firearms.

A completed fingerprint card must be submitted to the FBI along with an Application to Restore Federal Firearms Rights (OMB-1123-0017).
