Title: Application for Benefits for Quality Veteran's Child Born With Disabilities

I am requesting Approval of this regulation and for an Exemption for the Application for Benefits for Qualifying Veterans and that I certification related to occupation, on my behalf and as Federally recognized, request the Secretary of the Department of Veterans Affairs for payment attributable to increased usage of benefits as a result of transfers of entitlements to basic educational assistance from the Department of Defense Education Benefits Fund established from Appropriations made to the Department of Transportation, to allow the Secretary's decision confirming myself as parent has a service-connected to disability permanent in nature. Effective 01/19/2026

I am requesting enactment of the Veterans Benefits and Health Care Improvement Act of 2000, enactment of the Veterans Millennium Health Care and Benefits Act as amended, the enactment of the Veterans Benefit Act of 2003, and the enactment of the National Defense Authorization Act for Fiscal Year 2002, on my behalf and my request to the Secretary of Veterans Affairs to implementation of the Acts, the redesignations of entitlements by revisions of cross-references, conforming amendments to which relate, allow for provisions of certificate law of eligibility and award letters, allow for retroactive effective date of law regarding change to entitlements, employment and training, allow for home loans, allow for benefits for children of certain Korea service veterans born with disabilities, and the provisions of care under Veterans Community Carr Program upon determination of eligibility by this written statement of affirmation of judicial form and by Veterans' referring clinicians.

This is my Final Decision and Declaration of Rule Making Policy, for proper confidential public notice in

the Federal Register by approval of incorporation of reference of the Director of the Federal Register and the Director of the Office of Management and Budget, and Department of Transportation, all agencies and departments involved, under the Acts of Congress and the Constitution of the United States and United Nations, for this Direct Final Rule for the Enforcement of Civil Justice and the Protection for Civil Employees of the United States Federal Government for immediate effect upon release by the President of the United States and Secretary of Energy for this Mission. I am extremely grateful to President Trump and your entire Administration for the continuous efforts and actions related to peace and economic growth for the United States and the Federal Government.
