Getting Started

The FCC Part 43 system allows you to submit filings to fulfill the annual reporting requirements for international service.

New reports, revisions and waiver requests can be filed for:

- Circuit Capacity Report

Who must file a Circuit Capacity Report?

- Any U.S. common carrier that owned or leased bare capacity on a submarine cable between the United States and any foreign point on December 31 of the reporting period.
- Any person or entity that held a cable landing license on submarine cable between the United States and a foreign point on December 31 of the reporting period.

 **Enhanced Security for FCC CORES/Username starting March 29, 2024:**

Beginning March 29, 2024, 2-step authentication will be mandatory to login to the FCC'S Commission Registration System (CORES) and its associated FCC User Registration System. Paying application fees, requesting an FCC Registration Number (FRN) or updating an FRN Password require accessing FCC CORES with a Username Account. - To create a new filing or waiver request


