My name is Debra and I live in Long Beach California, I am currently on the EHV (emergency housing Voucher program), unfortunately I received a letter from the housing authority stating that due to lack of funding I will no longer get assistance and I am left to pay full rent, now as I continue to read the letter it also stated that HUD has given the housing authority permission to transfer me over into the HCV (housing choice voucher program),unfortunately that did not happen due to lack of funding for that program so they were unable to transfer "all" participants.... I am a senior citizen who lives in Long Beach whom is disabled, I currently receive SSDI and is unable to afford to pay my rent... I am a legal citizen of the United States and I have worked all my life starting at the age of 14, unfortunately I became disabled and I should have been one of the ones to be transferred into HCV.... I was told that HUD has given the housing authority a waiver to put me on the waiting list for HCV program and when funding is available I would be contacted... So that leaves me homeless with no where to go and helpless with a disability.... I pray and asked whomever is in charge of releasing funding for these programs to understand that there are legitimate people whom is in need of the government help such as myself.... Please don't allow more lives to be displaced.
