Title: Transfer of Functions for the Domestic Emergency Support Teams of the Department of Justice to include the Appointment Clause for the Criminal Division

I am requesting Approval of the proposed Order for Designation as Senior Advisor to the Office of the Attorney General and Designated First Assistant United States Attorney, to restate this Order to allow incorporation of all functions of other officers of the Department of Justice authorizing the Secretary of Homeland Security, Secretary of Labor, and the Commissioner to carry out responsibilities to ensure that all grants and contracts are awarded for personnel employment assistance, traineeships, provisions of technical assistance and allow for Transfers and Reimbursements the balance of appropriation assigned under law within the Department of the Treasury to to credit to an applicable existing or new appropriation account by the authority of the President of the United States, on my behalf and request by Oath confirming affirmation of judicial form in the States of the United States by incorporation of association by import.

The enactments the Grants and Contracts for Personnel Training Act, the Adult Education and Family Literacy Act, the Workforce Innovation, the Opportunity Act as amended by repealed Section 121e, and my request to the Director of the Office of Management and Budget and the Secretary of Homeland Security for enactment for related references of Domestic Security, the Department of Homeland Security's Reorganization Plan of November 25, 2022 to allow the Transfer of Personnel, assets and obligations and functions to be carried out in accordance with my Consent and Authority of Office for the Federal Government and the Acts of Congress under the Constitution of the United States.
