Methods:

The ALPA questionnaire will use REDCap to collect data annually from the project managers of CDC-funded lead poisoning prevention programs of state, tribal, local, and territorial governments. The link will be sent via an invitation email by a CDC staff member to the attention of all project managers of the funded programs during the annual budget period. A follow-up email will be

sent to those who have not responded after a sufficient amount of time.

Collection of Info, Data or Biospecimen:

Data will be collected electronically using a web-based link to a REDCap survey. This method was chosen to reduce the overall burden on respondents and does not require any special technical expertise or proprietary software. The survey instrument was designed to collect the minimum information necessary for the purpose of this information collection.
