Title: Overdose Data to Action Cooperative Agreement

I am requesting Approval for the Centers for Disease Control and Prevention's removal of previous approved instruments of overdose surveillance and prevention that are no longer active for on-going data collection purposes and revise burden, on my behalf and my request to the Directors of the Office of Management and Budget. This Approval and Delegation request, to the Director of Regulatory Affairs and the Secretary of Health and Human Services Department, includes removal of Evaluation and Performance Measurement Plan templates, Data Management templates, Organizational Capacity Assessment, Annual Reporting and Activity Progress Report and Work Plan tool, and b the Authority of the Secretary of Regulatory Affairs shall conduct Service, and encourage, cooperate with, and render assistance to the appropriate public authorities for investigations for the experiments, scientists in the conduct, scientific institutions and other actions, relating to the cause, diagnosis, treatment and prevention of impairment to individuals exposed to improper water purification, sewage treatment malfunctions and environmental pollution from lakes and streams. Effective 02/15/2026 for immediate effect of surveillance measures.

I am requesting the Secretary of Health and Human Services for Determination, Approval, Certification and to Redesignate by the enactment of the Secretary of the Department of Health, Education, and Welfare Act, the Department of Education Organization Act, An Act to Establish Offices of Inspector General establishment, and enactment and provisions for the Commemorative Works Act and Amendments and Repeals, to assist with the Inapplicability of Information by the National Research Institute for coordination of Federal Information Policy with the Office of Information and Regulatory Affairs, for their Authority and functions of the Director, assignment of tasks and deadlines and assignment of Federal Agency Responsibilities, per this written statement of Consent by Oath confirming my judicial for of affirmation by reference of incorporation under the States of U.S. Territory and

association by import.

I am requesting the Secretary of Health and Human Services, as reference to Department, Secretary, Department of Health, Education, Welfare and the Secretary of Health, in any law, rule, regulation, shall be deemed to refer and apply to the Department of Health and Human Services or the Secretary respectively, except to the extent such reference is to a function or office transferred to, shall promote efficiency among all programs, and shall seek to coordinate, significantly affecting individuals carried out under the Department of Education, by enactment and provisions of the Secretary of the Department of Health, Education, and Welfare Act. By my request of the Secretary of HHS, to make available to individual and entities, for biomedical and behavioral research, substances and living organisms, made available through contractors under such terms and conditions for payment for them, as the Secretary seems appropriate. The amounts collected through contractors shall be credited to the appropriation accounts and remain available until expended for carrying out the activities under such accounts.

This is my Decision of Rule Making Policy for my Direct Final Rule and Final Opinion for Agency enforcement of all applicable Agency Requirements for functions or offices for such period of time as may reasonably be needed to facilitate the orderly implementation of the Act.
