Summary of Changes from the Previously Approved Collection

- There have been no changes made in the Information Collection VA Form 26-4555c.
- No public comments were received during the 60-Day comment period.

A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

Title 38, U.S.C., chapter 21, authorizes a VA program of grants for specially adapted housing for disabled Veterans or service members. Section 2101(a) of this chapter specifically outlines those determinations that must be made by VA before such grant is approved for a particular Veteran or service member. VA Form 26-4555c is used to collect information that is necessary for VA to meet the requirements of 38 U.S.C. 2101(a). Also, see 38 CFR 36.4402(a), 36-4404(a), and 36.4405.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

The form is used by Loan Guaranty personnel in approving the benefit available under 38 U.S.C. 2101(a). The information requested is necessary in order to determine if it is financially feasible for a Veteran or service member to reside in specially adapted housing and to compute the proper grant amount.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

This form is available in a fillable electronic format on the One VA forms website at <http://www.va.gov/vaforms>. Once a determination on eligibility is made and the

file is reviewed by Loan Guaranty personnel, the Veteran or servicemember is directed to complete VA Form 26-4555c with instructions. An electronic submission system would not allow for personal customer service, and would delay applications from being processed due to errors. VA will continue to explore the use of information technology to submit this form.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

The information collected on VA Form 26-4555c is unique to VA and is not duplicated in other agencies' records or in other VA records.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

The collection of information does not involve small businesses or entities.

The information collected on this form is completed by Veterans who are applying for assistance in acquiring specially adapted housing. The data furnished on this form is essential to determining grant approval under 38 U.S.C. 2101(a). The collection is generally conducted only once.

a. Number of yearly respondents totals = 1,400.

b. Frequency of Response: One-time.

c. Annual burden total: 350 hours.

- d. The estimated completion time: 15 minutes.
- e. The respondent population for VA Form 26-4555c are Veterans and Service members applying for the Loan Guaranty Specially Adapted Housing Grant Program. VBA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents' costs associated with completing the information collection.

VA assumes a fully loaded hourly wage rate for a Veteran of \$33.80 calculated as the hourly median wage rate for All Occupations (Occupation Code 00-0000) of \$23.80 from the [BLS Occupational Employment and Wage Statistics, May 2024](#), multiplied by a fringe benefits multiplier of 1.42 based on the ratio of private industry wages and salaries to total compensation over the most recent four quarters, available at <https://data.bls.gov/series-report?redirect=true>.

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$11,830 (350 burden hours x \$33.80 per hour).

This submission does not involve any recordkeeping costs.
