A. Justification

1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.

This is a request for revision of a currently approved information collect request. The Animal and Plant Health Inspection Service (APHIS) is asking the Office of Management and Budget (OMB) to approve, for 3 years, its use of these information collection activities in connection with animal disease handling training.

The Animal Health Protection Act (AHPA) of 2002 is the primary Federal law governing the protection of animal health. The law gives the Secretary of Agriculture broad authority to detect, control, or eradicate pests or diseases of livestock or poultry. The Secretary may also prohibit or restrict import or export of any such animal or related material if necessary to prevent spread of any livestock or poultry pest or disease. The AHPA is contained in Title X, Subtitle E, Sections 10401-18 of P.L. 107-171, May 13, 2002, the Farm Security and Rural Investment Act of 2002. [7 U.S.C. 8301 et. seq.].

The Animal and Plant Health Inspection Service (APHIS)'s Veterinary Services (VS) is responsible for administering regulations intended to prevent the introduction of animal diseases into the United States. VS Professional People Training (PPT) provides training on responses to animal disease events, sample collection procedures, and disease mitigation and eradication activities to private veterinarians and State, Tribal, military, international, industry, and university personnel. The courses are designed to prepare participants for activities dealing with a U.S. animal disease incident.

PPT uses the Nomination Request Form – Animal Disease Training to collect contact information needed to select applicants for PPT animal disease courses. The applicant's supervisor and the appropriate APHIS official must nominate and authorize candidates to attend courses. PPT could not conduct training without the information provided on the form.

2. Indicate how, by whom, how frequently, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.

APHIS uses the following information activity to collect contact information needed to select applicants for PPT animal disease training:

Nomination Request Form - Animal Disease Training (VS Form 1-5); (State, Local, Tribal Government; Business; Individual)

VS collects information using VS Form 1-5 from private veterinarians as well as State, Tribal, military, international, university, and industry personnel who want to attend PPT animal disease training. PPT requires the applicants' work addresses, work telephone numbers, work email

addresses, agency/organization affiliations, supervisors' names and email addresses, and job titles. PPT uses this information to produce participant rosters after participants select courses and during training to encourage ongoing working relationships between course participants. Applicants submit the completed form (Web-based) before the PPT course date. The appropriate APHIS official selects applicants based on the need in their respective States for such trained personnel. VS Form 1-5 is subsequently sent to a PPT Program Specialist for processing.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submissions of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

APHIS makes every effort to comply with E-Government Act, 2002 (E-Gov) and to provide for alternative submission of information collections.

The agency anticipates 100% of applicants will register for and submit applications for PPT training by accessing AgLearn (a USDA Learning Management System) at <http://www.aglearn.usda.gov/> or by completing a course application survey through SurveyMonkey via a provided link.

4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purpose described in item 2 above.

APHIS solely administers regulations intended to prevent the introduction of animal diseases into the United States; as such, VS Professional People Training (PPT) provides training on responses to animal disease events, sample collection procedures, and disease mitigation and eradication activities to private veterinarians and State, Tribal, military, international, industry, and university personnel. The information collected in connection with this program is not available from any other source and every effort has been made to avoid duplication.

5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.

APHIS estimates 5 percent of the anticipated respondents for this collection are small businesses or other small entities. Most small business respondents are private veterinarians who may not have access to the Internet to register for PPT courses.

6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.

This is an ongoing voluntary information collection request. If the information was collected less frequently or not collected at all, it would significantly affect APHIS' ability to eradicate animal diseases. PPT provides training on the processes and activities needed to mitigate and eliminate harmful animal diseases that could affect human health. The absence of this training and work would increase the possibility of an animal health disease incursion, elevating the risk of adverse effects on U.S. public health, food, animal health and agriculture, and U.S. trade.

7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with the general information collection guidelines in 5 CFR 1320.5.

- **requiring respondents to report information to the agency more often than quarterly;**
- **requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**
- **requiring respondents to submit more than an original and two copies of any document;**
- **requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;**

The information collection is conducted in a manner consistent with the guidelines established in 5 CFR 1320.5.

Describe efforts to consult with persons outside the agency to obtain their views on the availability of data, frequency of collection, the clarity of instructions and recordkeeping, disclosure, or reporting form, and on the data elements to be recorded, disclosed, or reported. APHIS contacted the following respondents by email and phone and engaged in productive consultations associated with this program to discuss the information collected to administer its training. We discussed the overall need for the data; possible changes to the data/respondent

pool, reporting formats and other collection instruments; and the clarity of, and necessity for, any recordkeeping requirements. The respondents had no concerns with any of these items and had no further recommendations.

On Wednesday, 01/21/2026, APHIS published in the Federal Register (91 FR No. 13 Page 2518) a 60-day notice seeking public comment on its plans to request a 3-year renewal of this collection of information. APHIS received 6 comments (submitted with this request). Overall, commenters agree that the information collection is necessary, beneficial, and supportive of APHIS' mission, while one commenter recommended strengthening animal-welfare-focused components of the training curriculum

9. Explain any decision to provide any payment or gift to respondents, other than reenumeration of contractors or grantees.

This information collection activity involves no payments or gifts to respondents.

10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

January 2026, Tonya Woods, the APHIS Privacy Act Officer reviewed this collection and provided this statement for the data being collected and responded as follows: “While this data collection is not associated with a System of Records Notice, we provide private, safeguard, and protect in accordance with the privacy principles outlined in USDA Departmental Regulation 3515-002: Privacy Policy and Compliance for Personally Identifiable Information (PII).”

Any and all information obtained in this collection shall not be disclosed except in accordance with 5 U.S.C. 552a. APHIS’ Privacy Officer, Tonya Woods, reviewed the information requirement and concurred with the safeguards currently in this collection.

This information collection activity will ask no questions of a personal or sensitive nature.

12. Provide estimates of the hour burden of the collection of information. Indicate the number of respondents, frequency of response, annual hour burden, and an explanation of how the burden was estimated.

A) Indicate the number of respondents, frequency of response, annual hour burden, and an explanation of how the burden was estimated. APHIS is seeking approval for 350 respondents (affected public: 50 individuals, households, 50 businesses (accredited veterinarians), 250 State/Tribal staff), 350 total annual responses and 117 total annual burden hours. Respondents are veterinarians, post-secondary agricultural science teachers, and animal health scientists.

Burden estimate breakouts were developed from discussions with State, industry, Tribal, military, international, and university personnel who would likely attend a PPT training course (such as veterinarians, college professors, and State animal health officials). See APHIS Form 71. There are no recordkeeping or third-party disclosure burdens.

B) Provide estimates of annualized cost to respondents for the hour burdens for collections of information, identifying and using appropriate wage rate categories.

APHIS estimates the total annualized cost to these respondents to be \$8,335. APHIS arrived at this figure by multiplying the hours of estimated response time (117 hours) by

the estimated average hourly wage for the respondents (\$49.87) and then multiplying the result (\$5,834.40) by 1.4286 to capture benefit costs.

The average hourly wage used to calculate the estimates include the following:

The average hourly rates used to calculate the estimate were found at the U.S. Bureau of Labor Statistics website https://www.bls.gov/oes/current/oes_stru.htm.

According to news release [USDL-25-02335](#), released March 14, 2025, benefits account for 30 percent of employee costs, and wages account for the remaining 70 percent. Mathematically, total costs can be calculated as a function of wages, resulting in a multiplier of 1.4286.

Provide estimates of the total annual cost burden to respondents or recordkeepers resulting from the collection of information (do not include the cost of any hour burden shown in items 12 and 14). The cost estimates should be split into two components: (a) a total capital and start-up cost component annualized over its expected useful life; and (b) a total operation and maintenance and purchase of services component.

No cost burden is associated with capital and startup costs, ongoing/operation and maintenance expenditures, and purchase of services.

See APHIS Form 79. The annualized cost to the Federal Government is estimated at \$6,176.

APHIS is seeking approval of a revision of a currently approved information collection request. The currently approved burden for this request is 350 total annual respondents, 350 total annual responses, and 116 total annual burden hours. This request for a renewal is for 350 respondents, 350 estimated responses and 117 estimated burden hours. This request reflects an increase of 1

hour of estimated burden from the previous renewal request, most likely from rounding and from APHIS moving 50 respondents from business and now counting them as individual respondents.

There are no third-party disclosures.
