Individuals interested in participating in the Nurse Corps SP must submit an application to the Nurse Corps through the My BHW online portal. An agency may not conduct or sponsor, and a person is not required to respond to, a collection of information unless it displays a currently valid OMB control number. The OMB control number for this information collection is 0915-0301 and it is valid until 12/31/2028. This information collection is required to obtain or retain a benefit (Section 846(d)-(i) of the Public Health Service Act, as amended [42 U.S.C. 297n(d)-(i)]). The information is protected by the Privacy Act, but it may be disclosed outside the U.S. Department of Health and Human Services, as permitted by the Privacy Act and Freedom of Information Act, to Congress, the National Archives, and the Government Accountability Office, and pursuant to court order and various routine uses as described in the System of Record Notice 09-15-0037. Public reporting burden for this collection of information is estimated to average 0.61 hours per response, including the time for reviewing instructions, searching existing data sources, and completing and reviewing the collection of information. PART 1 | INTRODUCTION

APPLICATION LANDING PAGE USER GUIDE

Purpose: The online Application Landing Page user guide is a vital tool for the Customer Care Center. It helps answer questions and resolve issues that applicants face while navigating the page's programs and functionalities. By providing analysts with detailed insights, step-by-step instructions, and troubleshooting tips, the guide enhances their ability to support users effectively throughout the application process. This improved proficiency enables BHW Analysts to offer timely and accurate assistance, ensuring a smoother and more productive experience for applicants. Ultimately, the guide aims to improve user satisfaction and efficiency, facilitating successful engagement with the various programs offered.

Roles: The Application Landing page will be the, “homepage” for external users. The Customer Care Center Analysts need to understand the functionality to support external users should they encounter any problems with the Application Landing or homepage.

Precondition: Applicant has a question regarding the Application Landing page and contacts the Customer Care Center for help to resolve an issue.

PART 2 | APPLICATION LANDING PAGE

Upon logging in, the Bureau of Health Workforce (BHW) requires that all Applicants navigate to the Application Landing page. From here, the applicant can perform a multitude of actions and checks. This section of the user guide will highlight those features and how they perform.

THE APPLICATION LANDING PAGE LAYOUT

Once an applicant has either created an account or logged in using their existing account, the applicant will arrive to the Application Landing page. The Application Landing page is organized into different cards based on instruction and Program. The user will see a brief instruction throughout regarding the purpose of the page or Program as well as the Program organized by its type of (re)payment. For example, the Loan Repayment Programs for PSLRP, STAR LRP, FLRP, and S2S LRP, are found under the 'Loan Repayment Programs' section.

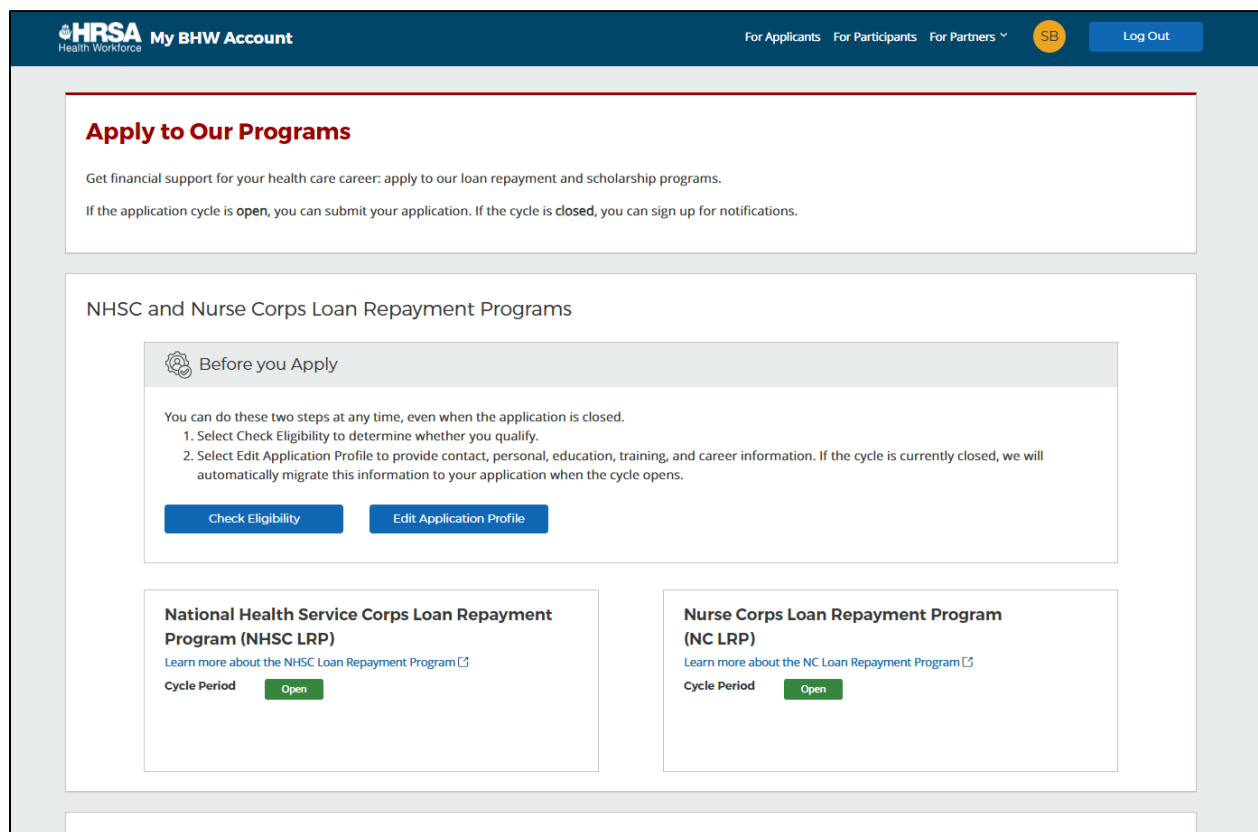


Figure 1: Application Landing Page

STEPS

1. The applicant either creates a BHW account or logs in using an existing account.
2. The applicant will interface with the landing page and utilize its features depending on the Program they are applying for.
 - Depending on the eligibility of the applicant and program cycle period, the applicant will experience various features and notice different statuses, which can be read more about in Part 3.

THE (MOBILE) APPLICATION LANDING PAGE LAYOUT

Like the Desktop Application Landing page above, the applicant also can view the same landing page, but within a mobile-phone version. The layout is condensed for better user interface and performs the same. See a screenshot below for better reference.

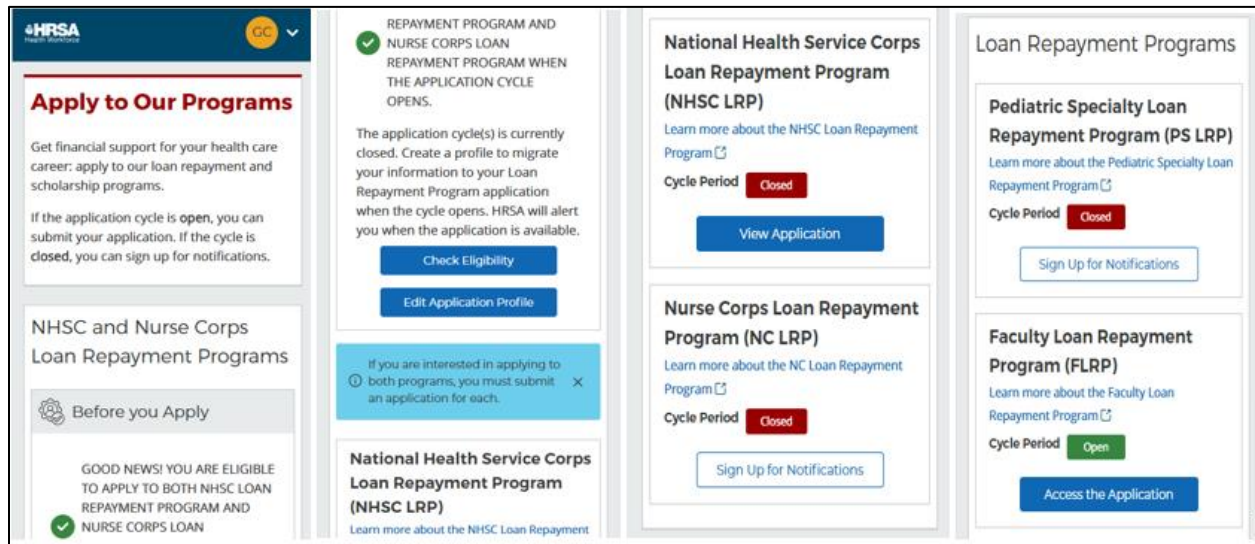


Figure 3: Application Landing Page (Mobile Version)

STEPS

1. From the applicant's mobile device, the applicant arrives to the landing page after creating a BHW account or logs in using an existing account.
2. The applicant with interface with the landing page and utilize its features depending on the Program they are applying for using the mobile-responsive design.
3. The user may scroll upward and downward in this column framed format.

Disclaimer: As of January 2025, the Application Landing mobile version only displays this user interface on select phones. Tablets such as an iPad will still function but be an eye-sore until future features are designed. Figure 3 (above) is presented horizontally to showcase the elongated layout even though a user would scroll from top to bottom.

PART 3 | CYCLE PERIOD STATUSES AND ACTION BUTTONS

CYCLE PERIOD STATUS

From the Application Landing Page, the applicant may view one of two cycle period statuses depending on the stage of the Program cycle status on the application cards.

The cycle period statuses include:

- 'Open', which is green-colored or,
- 'Closed', which is red-colored.

There is a Cycle Period status for every respective Program.

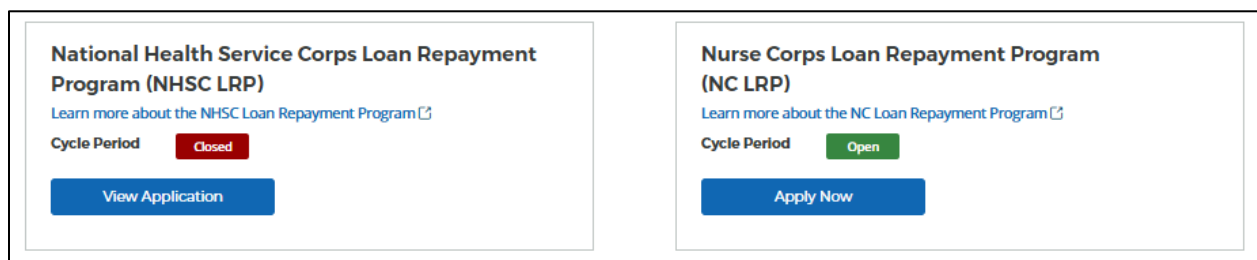


Figure 4: Cycle Period (Open & Close) Statuses

STEPS

1. The applicant successfully logged in to view the cycle period statuses either via their desktop or mobile device.
2. The "Cycle Open" status occurs when the date is between the program cycle open and cycle deadline.
3. The "Cycle Close" status occurs when the date is pre-program cycle open or post cycle deadline, including fiscal year end close.

ACTION BUTTONS

While viewing the Application Landing Page, the applicant may utilize various action-buttons depending on their eligibility, program cycle status, and application status.

Circumstances:

- **Apply Now** – if the application is not started and the cycle is open.
 - Clicking navigates to the welcome page for application.
 - Applicant status: Not Started
- **Continue Application**– if the application is in progress and the cycle is open.
 - Clicking navigates to the last saved page.

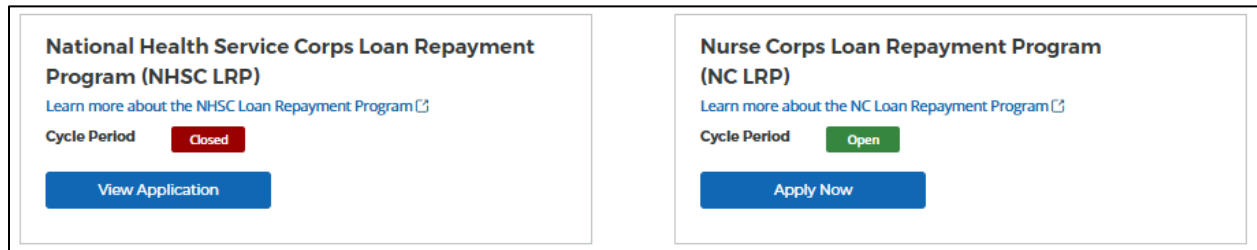


Figure 5: Action Buttons for 'View Application' and 'Apply Now.'

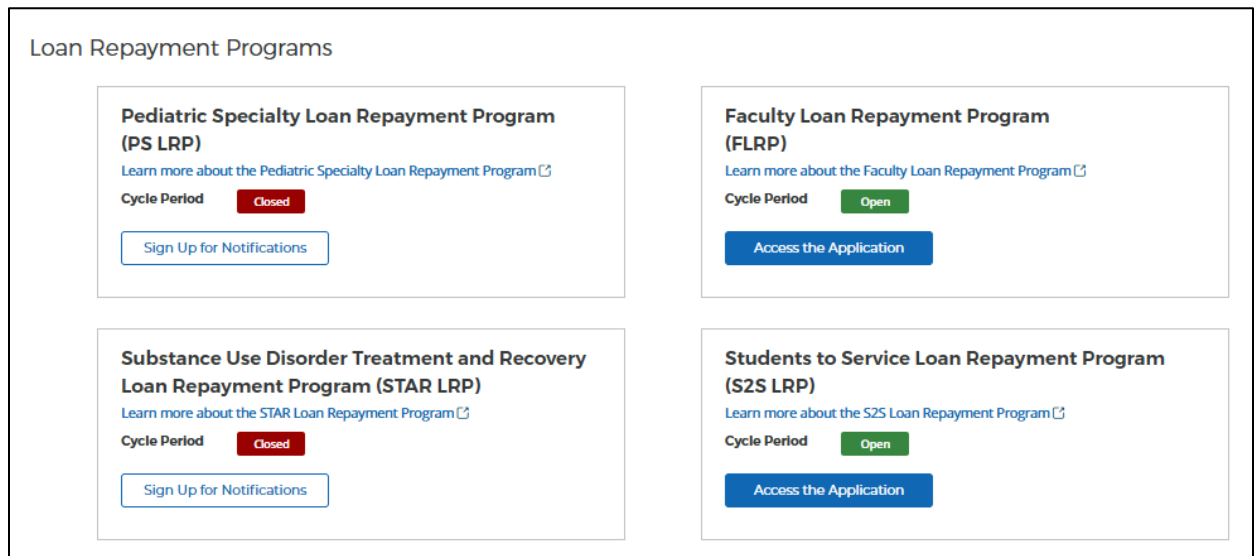


Figure 6: Action Buttons for 'Sign Up for Notifications' and 'Access the Application.'

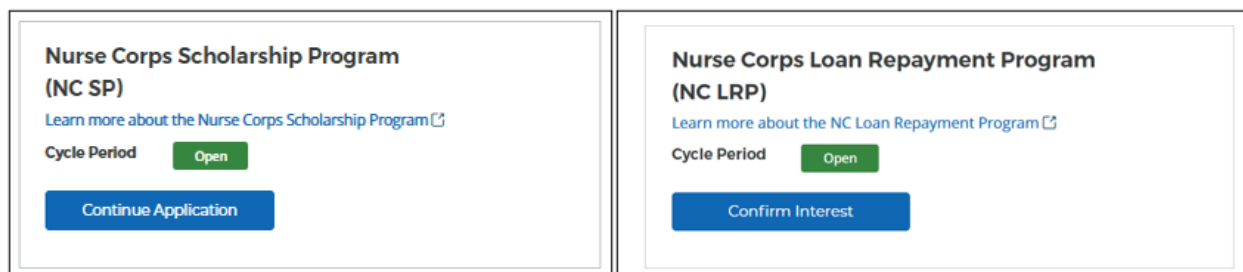
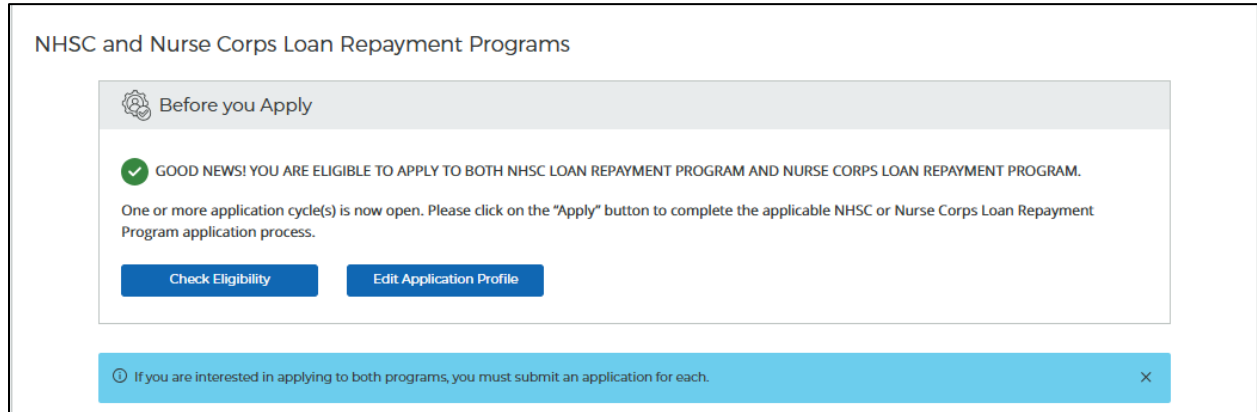


Figure 7: Action Buttons for 'Continue Application' and 'Confirm Interest.'

Circumstances:

- **Check Eligibility**
 - Upon logging in, if the applicant has not yet started the Pre-Application, they may do so by checking their eligibility.
 - The applicant may check their eligibility regardless of Program cycle period (open or close).
- **Create Application Profile**
 - Ahead of applying to either NHSC LRP or NCLRP, an applicant can create a profile whether the cycle is open or closed.
- **Edit Application Profile**
 - If the applicant has already created a profile, then the user shall be able to edit and view their applicant profile regardless of whether the Program cycle period is open or closed.
- **Apply Now**
 - The system shall be dynamically display 'Apply Now' on either of the NHSC LRP or NCLRP cards depending on the eligibility outcome of the Pre-Application.
 - Applicant status: Not Started
- **Sign Up for Notifications**
 - This action-button is displayed if the pre-application status is ineligible, and cycle is open.
 - This action-button is blank if the pre-application is not started, and the cycle is open.
 - Clicking on 'Sign Up for Notifications' navigates the user to the [HRSA Notifications Page](#).

- Applicant status: N/A

STEPS

1. The applicant successfully logged in to view the cycle period statuses either via their desktop or mobile device.
2. The applicant can verify their eligibility for either the NHSC LRP or NCLRP programs. Also, they have the option to create and/or edit their profile.
3. Depending on the outcome of their eligibility and the program cycle period the system will populate various actions in in the NHSC LRP and NCLRP program cards to select from.

The applicant may be either not eligible, eligible for only one Program, or potentially eligible for both Programs. Again, depending on the various scenarios, the applicant may also view different Success Messages, Cycle Messages, and/or Blue Banner messages. These can be seen in the table below.
