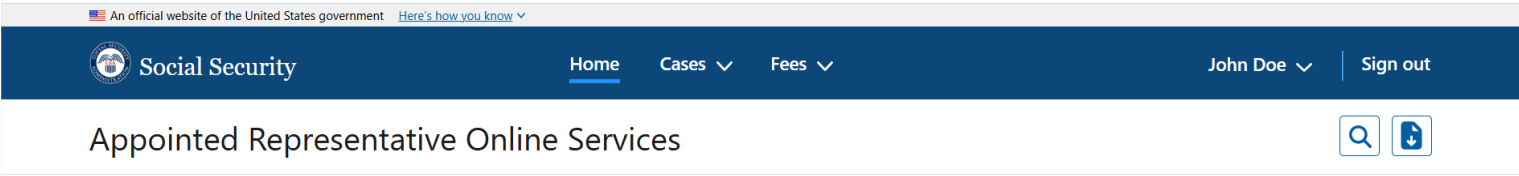

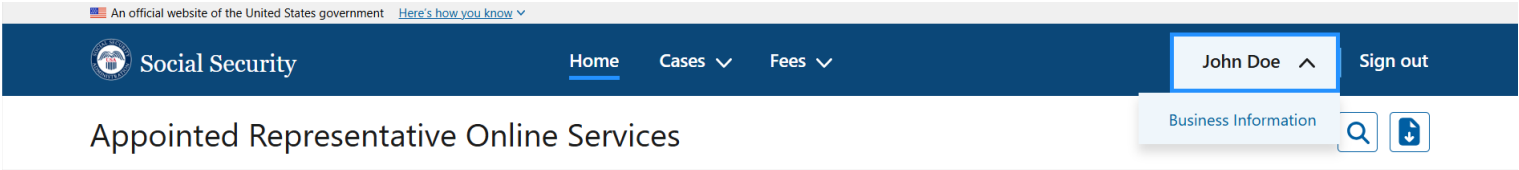

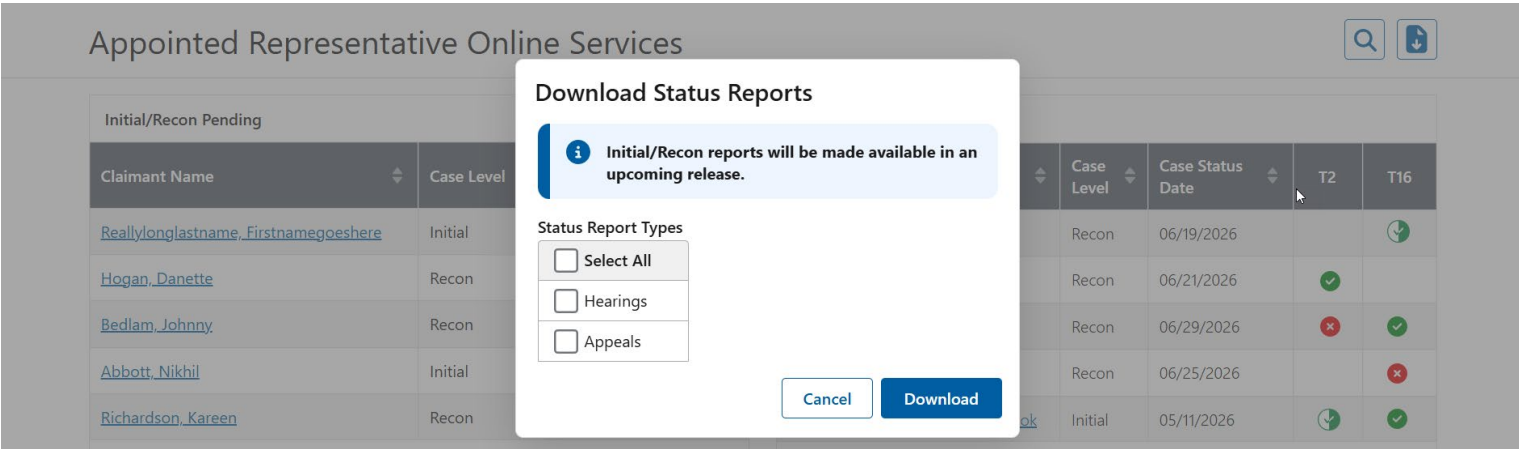


1.6 Header without Manage Access with Sign-On Name Tab Expanded
